#### **Water Report:**

5% Water loss. The wells are holding. We need to place a voluntary water restriction on the town until further notice.

#### **Sewer Project:**

The City Clerk explained that the best option to move forward with the sewer project is to place the electrical improvements at the lift station as the base bid and move the SAGR system to an alternate. A motion was made by Alderman Stone, second by Alderman Bradford to move the SAGR system to an alternate for phase 3. Motion passed 3-0, with Mayor Meek voting.

#### **Board Meeting Start Time:**

There was some discussion to change the start time of all future board meetings to 6:00 P.M. After some discussion, the board will try the earlier start time until November and then revisit the topic.

#### **New Business:**

#### **Old Fire House Repairs:**

Members were present from the Osborn Fire Protection District to discuss splitting the cost of replacing the roof on the old fire station. The City and OFPD would like to replace the roof with a metal one and repair the doors. The City Clerk explained that

Mike and the OFPD would have to directly solicit 3 bids. Pat Bestgen said they will discuss this at their next board meeting on Aug. 23. Mike will try to attend the meeting. After some discussion the topic was tabled until more information could be gathered.

# **Alderman Comments:**

Alderman Stone wanted to know if the City could do anything about dogs being chained up on properties. The Clerk stated that if a dog was chained up then the owner was following the City's leash law.
